Health and Safety Committee (should complete SHE Rep: Apply Safety, Health and Environmental Protection Procedures (Unit Standard 13223). It is highly recommended that all staff should complete Apply Health & Safety To a Work Area (Unit Standard 9964). The Occupational Health and Safety Act of 1993 require staff members to be appointed as health and safety representatives (SHE REPS) to inspect the workplace. The employer is required to provide health and safety training in order for them to perform their duties. It is the SHE REPS responsibility to prevent potential threats and non-compliance Issues, to report certain findings to management, to then discuss possible solutions in carefully structured Health & Safety Meetings, and finally to ensure the achievement of set goals. In order to give management a more realistic view of Happenings on the work floor, non-managerial Representatives are of vital importance to this progress SHE REPS must have a thorough knowledge and understanding of the legislative requirements (OSH Act), they must be aware of their Duties and responsibilities, and they must be familiar with all Administrative requirements involved in their Quest for Safety at the Workplace.

- Limit damage to persons or property in the case of an emergency.
- Follow procedures that apply to illness or injury in the work area.
